# AMY PUMP STATION IMPROVEMENTS OAKLAND COUNTY, MICHIGAN

Sealed proposals will be received by the Office of the Oakland County Water Resources Commissioner, Oakland County, Michigan, Building 95 West, One Public Works Drive, Waterford, Michigan 48328-1907 ("Owner") for the construction of certain facilities and structures, including the following approximate quantities:

## Maintenance Improvements to Amy Pump Station

- 1) Audio video survey of pre-construction conditions.
- 2) Generator replacement including removal of the existing indoor diesel generator, providing a temporary portable generator during construction, new outdoor natural gas generator, new Automatic Transfer Switch, Manual Transfer Switch, and all associated work including conduit and wiring for both temporary use during construction and permanent service at construction completion, concrete foundation, walkways around generators and related work as indicated.
- 3) Replacement of three existing flowmeters including removal of existing, new meters including all associated conduit and wiring as indicated.
- 4) Roof replacement and deck infill.
- 5) Miscellaneous architectural work including exterior masonry cleaning and resealing, removal of existing louvers associated with the indoor generator, louver replacement for a MAU including incidental mechanical work, brick infill at locations of removed louvers, and painting of walls and floor in the electrical room.
- 6) New 480 V distribution panel, removal of existing MCC and all associated work including conduit and wiring for both temporary connections during construction and permanent connections at construction completion.
- 7) New pump station control panel and all associated work including programming, conduit and wiring as indicated.
- 8) Relocation of electrical, temperature control and telemetry equipment, including all associated conduit and wiring.
- 9) Replacement of three existing check valves including removal of existing and providing new valves including new flange hardware and flange gaskets.
- 10) Site soil and sedimentation control.
- 11) Landscaping and restoration.
- 12) Allowance for modification to existing natural gas service.
- 13) Allowance for SCADA improvements by the Owner's preferred integration vendor.

### LTCAP Improvements to Amy Pump Station

- 1) Selective demolition and removal of three existing pumps, liquid drives and motors and all associated work including disconnection of industrial water supply to the drives.
- 2) Replacement of three solids handling pumps with new pumps having larger impellers, new 50 hp pump motors, grouting of new pumps and motors, seal water improvements consisting of new seal water pots and associated plumbing and support work, and electrical work including new conduit and wire for the new pumps as indicated.
- 3) Removal, refurbishing and re-installation of three sets of extended pump line shafts, including new bearings, blasting and repainting of supports and guards.
- 4) Three new 50 hp variable frequency drives, one per pump, and all associated work including conduit and wiring for both temporary connections during construction and permanent improvements at completion of construction.
