
**INVITATION FOR BIDS
PIONEER PARK
CITY OF UTICA
MACOMB COUNTY, MICHIGAN**

Sealed proposals for the construction of the Pioneer Park project will be received by the City Clerk for the City of Utica, until 2:30 p.m., Local Time on **Tuesday, March 12, 2019**, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

Construction of a 22'x10' masonry restroom facility, 450 feet of 8" water main, 178 feet of 6' sanitary sewer lead. Project also includes 400 tons of HMA for parking lot and 10' wide Shared Use Path, 4,000 square feet of concrete sidewalk, 1,260 feet of 60-inch fence, site furniture including benches and tables, site grading, turf restoration, landscaping and other associated work as itemized in the proposal.

Copies of Plans and Specifications and Proposal Forms shall be available on or after **February 18, 2019** at the offices of Hubbell, Roth & Clark, Inc., Consulting Engineers, 555 Hulet Drive, Bloomfield Hills, Michigan 48302-0360. A non-refundable payment of One Hundred Fifty (\$150.00) Dollars, **CHECK ONLY, payable to "Hubbell, Roth & Clark, Inc."** will be required for each set of Drawings and Specifications. Drawings and Specifications can be shipped by U.P.S. ground for a shipping and handling charge of Forty (\$40.00) Dollars, **CHECK ONLY, non-refundable, to Hubbell, Roth & Clark, Inc.**

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a cashier's check or bid bond, executed by the bidder and Surety Company, payable to the City of Utica in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the City of Utica. No bid may be withdrawn after scheduled closing time for receiving bids for at least Sixty (60) days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The City of Utica reserves the right to reject all bids and to waive irregularities in bidding.
