- A1. The Wainstock pavement section is part of the Wixom details See sheet 2 of 2 Pavement Standards Plan sheet 14 in the set.
- Q2. The only two pay items for asphalt are item 59 and 60 which is 36A and 13A. What units cover Wainstock Street?
- A2. All of the pavement pay items are either 13A or 36A per the details. 13A covers Wainstock.
