The City of Bloomfield Hills is accepting Statements of Qualifications (STATEMENTS) from Contractors to provide on-going, as needed road rehabilitation and maintenance services for up to three (3) calendar years with the City's option to renew annually.

STATEMENTS for the 2020 Road Program will be received by Lia Michaels, P.E. via email at lmichaels@hrcengr.com, until 3:00 p.m., Local Time, on Wednesday, February 19, 2020. After said date and time no further STATEMENTS will be accepted or evaluated. The STATEMENTS will NOT be publicly opened and read. A list of proponents and the services they submitted for will be made available. It is not required that a hard copy of the STATEMENTS be sent to the City.

Requested services include, but may not be limited to; roadway replacement by mill & overlay, pulverize, or full-depth pavement removal; cut and patching, rout and seal, overband crack fill, remove and replace concrete curb and gutter, structure adjust with concrete collar, structure reconstruct with concrete collar, and other related and miscellaneous services and items of work necessary to maintain the City's road infrastructure, such as base repairs, subgrade undercuts, driveway repairs.

It is the City's desire to select the fewest number of Contractors able to perform a majority of the requested items of work. However, if in the best interest of the City, multiple Contractors for each item of work may be selected.

If a hard copy is desired, a non-refundable payment of Forty (\$40.00) Dollars, CHECK ONLY, payable to "Hubbell, Roth & Clark, Inc." will be required for each set. Hard copies of the Request for Statements of Qualification may be picked up at the offices of Hubbell, Roth & Clark, Inc., Consulting Engineers, 555 Hulet Drive, Bloomfield Hills, Michigan 48302-0360., or can also be shipped by U.P.S. ground for an additional shipping and handling charge of Twenty (\$20.00) Dollars, CHECK ONLY, non-refundable, to Hubbell, Roth & Clark, Inc.

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

No STATEMENT may be withdrawn after scheduled closing time for receiving STATEMENTS for at least 120 days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.
