Proposals received via drop box must be submitted on **Monday July 13, 2020 only** and must be received before **4:00 p.m., Local Time on Monday July 13, 2020**. Bid opening will commence at **4:10 p.m. Local Time on Monday, July 13, 2020** and will be read at the Township. Description of Work

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

The project consists of repaving of the existing roads within the in Sandalwood Condominiums including North Adams Way, South Adams Way and Justin's Court. Other work includes: select aggregate base repairs; removal and replacement of driveway approaches, placement of new leveling and wearing courses of HMA; traffic control; lawn restoration; and soil erosion control measures in the Sandalwood Condos in Bloomfield Township.
