Sealed proposals for the SAW Sanitary Sewer Cleaning And Televising project will be received at the **Bloomfield Township Dave Payne Public Services Building** (part of the 4200 Telegraph Rd complex – see **location map in Appendix A**) via the dropbox until **10:00 a.m. Local Time on Monday, September 21, 2020**, at which time and place all bids will be remotely opened and read. Bid opening will commence at **10:15 a.m. Local Time on Monday, September 21, 2020** and will be read at the Township. **Cleaning and televising about 230,000 feet of sanitary sewers with heavy cleaning where needed to access the sewer with CCTV.**
