The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

Approximately 0.33 miles of water main replacement with road reconstruction, 0.85 miles of roadway pavement replacement by mill & overlay and other miscellaneous items as indicated in the Proposal. Project is located on Rathmor Road and West Valley Road, local streets located on the north side of W Long Lake Rd, between Lahser Rd and Woodward Ave.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the City of Bloomfield Hills in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the City of Bloomfield Hills. No bid may be withdrawn after scheduled closing time for receiving bids for at least ninety (90) days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The City of Bloomfield Hills reserves the right to reject all bids and to waive irregularities in bidding.

No Proposal will be received unless made on blanks furnished and delivered to the City Clerk on or before 3:00 p.m., Local Time on Tuesday, February 23, 2021.
