Also, the Authority reserves the right to reject the Bid of any Bidder if the Authority believes that it would not be in the best interest of the Project to make an award to that Bidder, whether because the Bid is not responsive or the Bidder is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by the Authority.

The undersigned agrees to furnish the required bonds and insurance certificates within seven (7) days after the acceptance of this proposal and further agrees to start construction within ten (10) days after being notified that work can begin.

Time is of the essence for completion of this project in order to have this project ready for SCCMUA's use. The bidder guarantees that he or she can complete the work with the time limit stated or as extended. It is mutually agreed the damages to the Owner for such delay and failure on the part of the Bidder shall be liquidated in the amount of **Three Hundred Dollars (\$300.00) for each and every calendar day by which the Bidder shall fail to complete the work or any part thereof within the provisions hereof, and such liquidated damages shall not be considered as a penalty.**

The company representative does warrant that by signing the bid documents, the additional insured endorsement will be included in the insurance coverage supplied to the Authority as part of the specified requirements. All sewer lining construction shall be substantially completed by **August 15, 2021**. All construction, including restoration, shall be completed by **September 15, 2021**.
