Sealed proposals for the construction of the General Motors Road Rectangular Flashing Beacon project will be received by the Township Clerk for Milford Township, until 10:00 a.m., Local Time on Wednesday, July 14, 2021, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

Installation of Push Buttons and Rectangular Rapid Flashing Beacons for the sidewalk crossing at the intersection of General Motors Road and Martindale Road, as well as ramp improvements to meet ADA compliance. **The Contractor must be MDOT prequalified in Electrical Construction.**

Copies of Plans and Specifications and Proposal Forms shall be available on or after 12:00 p.m. on June 23, 2021. **Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.**

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to Milford Township in the amount of five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with Milford Township. No bid may be withdrawn after scheduled closing time for receiving bids for at least sixty (60) days.
