The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

The project consists of sanitary sewer televising with sewer condition coding per the National Association of Sewer Service Companies (NASSCO) Pipe Assessment Certification Program (PACP). Condition assessment shall be performed by a NASSCO PACP certified individual with a current certification. The entire project area consists of a total of 163,800 linear feet (LF) ranging in size from 4- to 24-inch as follows:

- 1. 800 LF of 4-inch diameter sewer.
- 2. 142,000 LF of 6-inch to 12-inch diameter sewer.
- 3. 21,000 LF of 15-inch to 24-inch diameter sewer.

Project also includes sanitary sewer cleaning of up to 163,800 LF, ranging in size from 4- to 24-inch, where necessary.
