

ADVERTISEMENT FOR BIDS
CWSRF MARYSVILLE WWTP PARALLEL INFLUENT SEWER
MARYSVILLE, MI

Sealed proposals for the construction of the CWSRF Marysville WWTP Parallel Influent Sewer will be received by the City of Marysville City Clerk **until 2:00 p.m., Local Time on Thursday, March 31, 2022** at the City of Marysville City Hall, 1255 Delaware Ave. Marysville, MI 48040 at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

Remove existing upstream sanitary manhole and construct a new junction chamber. Additionally, install approximately 100 feet of 24" Class V RCP parallel relief sewer from junction chamber to a new 48" Sanitary Manhole and then approximately three (3) feet of 24" Ductile Iron to the WWTP headworks including related work as shown in the plans.

A pre-bid meeting is scheduled for **March 9th, 2022 at 10:00 a.m.**, local time, at the Marysville WWTP, 980 Huron Blvd, Marysville, MI 48040. This meeting will be attended by the Owner, Engineer, and other interested parties. At this meeting, questions regarding the bid documents will be answered and Contractors will be allowed to inspect the work site.

Copies of Plans and Specifications and Proposal Forms shall be available on or after **Tuesday, March 1, 2022**, at the offices of Hubbell, Roth & Clark, Inc., Consulting Engineers, 555 Hulet Drive, Bloomfield Hills, Michigan 48302-0360.

Copies thereof for bidding purposes may be obtained for a non-refundable payment of One Hundred Twenty (\$120.00) Dollars for each set of Contract Documents. An electronic copy (USB) and hard copy will be provided. **CHECK or CREDIT CARD will be acceptable. CREDIT CARD information can be provided over the telephone or via email, or CHECKS, payable to "Hubbell, Roth & Clark, Inc." can be mailed to the office.** Contract Documents can be shipped by UPS ground for an additional shipping and handling charge of Twenty-Five (\$25.00) Dollars, CHECK or CREDIT CARD, non-refundable, to Hubbell, Roth & Clark, Inc. The Bidder is advised that to submit a bid on this project, the Bidder must have requested an electronic copy or purchased a set of Contract Documents from Hubbell, Roth & Clark, Inc.

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the City of Marysville in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the City of Marysville. No bid may be withdrawn after scheduled closing time for receiving bids for at least Sixty (60) days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The City of Marysville reserves the right to reject all bids and to waive irregularities in bidding.

No Proposal will be received unless made on blanks furnished and delivered to the City of Marysville Clerk **on or before 2:00 p.m., Local time, Thursday, March 31, 2022.**
