Sealed proposals for the Oxford Road Pavement and Utility Rehabilitation will be received by the City Clerk for the Village of Grosse Pointe Shores, A Michigan City, until **11:30 a.m., Local Time on Tuesday, March 1, 2022**, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

The project consists of the partial reconstruction of Oxford Road, the replacement of an existing 6” water main with a new 8” water main utilizing pipe bursting and the installation of a new 12” sanitary sewer to include abandonment and removal of existing sanitary sewer.

The Bidder is advised that in order to submit a bid on this project, the Bidder must download and complete the Proposal Form (Section 00300) and include the required bid deposit with their bid submission.

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the Village of Grosse Pointe Shores, A Michigan City in the amount of Five Percent (5.00%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the Village of Grosse Pointe Shores, A Michigan City. No bid may be withdrawn after scheduled closing time for receiving bids for at least sixty (60) days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The Village of Grosse Pointe Shores, a Michigan City, reserves the right to reject all bids and to waive irregularities in bidding.

No Proposal will be received unless made on blanks furnished and delivered to the City Clerk on or before 11:30 a.m., Local Time on Tuesday, March 1, 2022.
