Sealed proposals for the **SAW Additional Televising Areas** project will be received at the **Bloomfield Township Dave Payne Public Services Building** (part of the 4200 Telegraph Rd complex – see **location map in Appendix A**) until **2:00 p.m. Local Time on Wednesday, May 18, 2022,** at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

Cleaning and televising of about 52,500 feet of sanitary sewers, with heavy cleaning where needed to access the sewer with CCTV.
