- 3. Return activated sludge pump station building including pumps, piping, and waste activated sludge piping with adjacent electrical room.
- 4. Tertiary filter and ultraviolet disinfection building including equipment, piping, and channels.
- 5. Final effluent water system.
- 6. Sludge digestion improvements
- 7. Dewatering building including dewatering screw press and conveyors to roll-off container.
- 8. Site work including WWTP access road, yard piping and valves, site and building utilities.
- 9. Installation of emergency generator.
- 10. WWTP SCADA installation.
- 11. Demolition of existing structures and DPW buildings.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted in hard copy form on the proposal forms in a sealed envelope clearly marked **"BID FOR WASTEWATER TREATMENT PLANT IMPROVEMENTS"** provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the City of Mason in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the City of Mason. No bid may be withdrawn after scheduled closing time for receiving bids for at least ninety (90) days.

The Contract awarded under this Invitation to is expected to be funded in part from the Michigan State Cleanwater Revolving Fund (CWSRF) and Environmental Protection Agency (EPA) Community Grants (CG) and Sewer Overflow and Stormwater Reuse Municipal Grant (OSG). CWSRF, CG, and OSG requirements are included in Section "Instruction to Bidders" and Section "Supplementary Conditions," and are a condition of this Contract. The Bid Proposal shall also include a breakdown of the amounts for the CG and OSG components which are described in detail on the "Bid Form." The Successful Bidder must comply with the Disadvantage Business Enterprise (DBE) Procurement requirements, Davis-Bacon Act and Section 70911 to 70917 of P.L.117-58 Build America Buy America Requirements as required for the applicable portions of the project.

The successful bidder will be required to furnish satisfactory Performance, Payment, and Maintenance and Guarantee Bonds. The Owner reserves the right to reject all bids and to waive irregularities in bidding.
