Sealed proposals for the construction of the Maxwell Court Storm Water Basin Rehabilitation will be received at the **Bloomfield Township, Dave Payne Public Services Building, 1553 Exeter Road, Bloomfield Township, MI 48302** (part of the 4200 Telegraph complex – see location map in Appendix A) until **10:00 a.m. Local Time on Monday, July 17, 2023** at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

**Description of Work**

Retention basin located between 3501 and 3515 Maxwell Court in Bloomfield Township. The following general areas of work will be performed:

- By-pass pumping
- Retention basin cleaning
- Structural concrete surface repairs, coatings and other repairs/modifications
- Wood fence repair
- Overflow pipe and outlet structure removal and replacement
- Miscellaneous landscaping

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the Township of Bloomfield in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary contract with the Township. No bid may be withdrawn after scheduled closing time for receiving bids for at least sixty (60) days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The Township reserves the right to reject all bids and to waive irregularities in bidding.

**No Proposal will be received unless made on blanks furnished and delivered to the Bloomfield Township Dave Payne Public Services Building on or before 10:00 a.m. Local Time on Monday, July 17, 2023.**

**All Bidders must meet the requirements set forth in the Township's prequalification statement. The Township will require at least three (3) satisfactory municipal references for similar work in the last two (2) years in Michigan for all contracts with a value greater than \$50,000.00.**
