### WWTP TRICKLING FILTER REPLACEMENT PROJECT BID #24-1004

Bids must be received in the Purchasing Department prior to 2:00 p.m. on the bid due date. All bids received after 2:00 p.m. on the bid due date will be returned to the bidder unopened.

The City of Bay City is soliciting sealed proposals for: **WWTP Trickling Filter Replacement Project Bid #24-1004**

This project includes the supply, installation and commissioning of two (2) new steelfused-to-glass Trickling Filter tank walls and dome, two (2) new 18 MGD rotary distribution mechanisms, and three (3) new 9 MGD, 100 hp, VFD speed controlled primary effluent vertical turbine pumps. The work includes new structural primary effluent pump pads, new primary effluent sampler system, and utility work. Demolition of the existing primary effluent pumps, trickling filter tank walls and dome, and rotary distribution system is included in the scope of work.

**There will be a MANDATORY pre-bid meeting on Tuesday, September 12, 2023, at 10:00 am at the Wastewater Treatment Plant located at 2905 N. Water Street, Bay City. This meeting must be attended in order to submit a bid. Bids will not be accepted unless bidder has attended the MANDATORY pre-bid meeting and signed the official attendance sheet. Vendor names must be clearly visible on external container of submitted bid package and match the vendor's name entered on official attendance sheet.**

**\*\*NOTE: Per Section 2-284 of the City's Code of Ordinances, all contractors must be deemed a Responsible Contractor by the City of Bay City, prior to submitting a bid on this project. Any Contractor who has not already been deemed a Responsible Contractor and wishes to bid on this project, must submit a Pre-Qualification Questionnaire at least three (3) weeks prior to bid opening. Pre-Qualification Questionnaires are available on the City's Purchasing webpage and must be submitted with all attachments via mail or email. The determination of Contractor Responsibility will be evaluated by the Pre-Qualification Review Committee. The Purchasing Department will send a Notice of Determination to the contractor by certified mail, stating whether the contractor has been determined to be Responsible or Non-Responsible\*\*.**

All bids will be publicly opened and read aloud at 2:00 p.m. on **Wednesday, October 04, 2023**, for the **WWTP Trickling Filter Replacement Project Bid #24-1004** all in accordance with the Bidding Documents, and as otherwise set forth herein.

### **Local Preference Policy**
