Sealed proposals for the construction of the Chesterfield Road Culvert Rehabilitation will be received by the City of Bloomfield Hills the until 9:00 a.m., Local Time on Thursday, March 21, 2024, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

The Project includes rehabilitation of two twin culverts on Chesterfield Road in Bloomfield Hills, Michigan. The Project requires geopolymer structural liner for the existing culverts, a new 18 inch culvert, guardrail and road repairs, and other miscellaneous items as indicated in the Proposal.

Bidders may obtain a copy of the Drawings and Specifications (Procurement Documents) for the project through either the MITN website, or by contacting HRC directly at lmichaels@hrcengr.com.

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the City of Bloomfield Hills in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the City of Bloomfield Hills. No bid may be withdrawn after scheduled closing time for receiving bids for at least ninety (90) days.

The successful bidder will be required to furnish satisfactory insurance documentation, and Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The City of Bloomfield Hills reserves the right to reject all bids and to waive irregularities in bidding.

No Proposal will be received unless made on blanks furnished and delivered to the City Clerk on or before 9:00 a.m., Local time, on Thursday, March 21, 2024.

All proposals shall be enclosed in sealed envelopes and labeled as indicated below. Sealed envelopes can be dropped off in the drop boxes located outside of City Hall. If mailed, the sealed envelopes containing proposals shall be inserted in a separate mailing envelope and addressed as follows:
